**Proxy**: If you will be unable to attend this meeting in-person or virtually, you may choose another member from the church to be your "proxy" for voting. A member may act as a proxy solely for one other member at a time. Your proxy appointment will be valid for up to eleven (11) months from the signing date of the proxy form.

#### Introduction and Robert's Rules of Order (Abbie Brown)

- How does the voting process work?
  - Motion is proposed, motion gets a 2<sup>nd</sup>, motion is discussed, moderator calls vote, congregation votes.
  - All motions from a committee (such as the Council or Nominating Committee) already have a 2<sup>nd</sup> included, so we start with discussion of the motion.
  - o If someone wants to amend a motion, they can propose an amendment. If there is a 2<sup>nd</sup> to amend, the amendment is discussed and voted on. If the amendment passes, we vote on the new amended motion. If the amendment fails, we go back to vote on the originally proposed amendment.

#### How does voting work during a hybrid in-person/virtual meeting?

- All those members in person will vote by raising their hand until they have been counted. For certain types of votes, a written ballot may be used.
- o If you are also voting as a proxy for another member, you will raise your hand and hold up two fingers. All proxies may only vote for one other member.
- All members attending virtually will vote using the comment feature on the Facebook livestream (see below).

#### Facebook Congregational Meeting Etiquette (if you are joining the meeting virtually) (Jen Dean)

- The meeting will be recorded for Urban Grace's records.
- When prompted, everyone will need to "sign in" in the comments by typing their name in the comment section of the Facebook livestream. Please type the names of each of the members attending (even if only using one Facebook account) so we know how many people are at the meeting and can establish quorum.
- If you have a question, comment, or want to amend a motion, please write your name along with your question, comment, and/or motion in the comment section of the livestream and it will be read aloud at the meeting. Anyone can ask questions or make comments, but only members of the church may make motions or vote.
- Voting will also be done within Facebook through the "Comment" feature. All members will be able
  to vote once for themselves and once as a proxy representative (as applicable). If you have more
  than one member in your household, each person can vote using separate Facebook accounts, or
  several members could vote using one account by putting the name and vote of each person in the
  same comment. For example, "Ferris Bueller votes yes. Marty McFly votes no. Princess Buttercup
  votes yes."
  - For certain types of votes, a link to a form will be made available for you to use.

#### **Church Budget Highlights**

- **Income:** We project \$252,000 from individual giving for 2025-26. This includes 30% from pledges and over 60% from consistent, regular giving seen in the last year.
- Cash Assets: Current cash assets are \$142,000, down from \$204,000 at this time last year.
- **Deficit:** We're ending the current fiscal year with a larger-than-expected deficit due to changes in giving and carry-over personnel costs.
- Relief Funds: We're maintaining an aspirational goal of \$500 for Relief Funds.
- Staffing (and reason for increases from last year's budget):
  - Includes budgeting for 5 staff people + childcare workers + sound techs (all part-time except for one full-time pastor)
  - 2.5% cost-of-living increase for non-executive staff starting January 2026.
  - Bonuses moved into Personnel from special giving. In previous years, the bonuses were paid by leadership. To provide more accessibility to being a leader, this was moved into the general budget.
- **Projected Deficit**: Based on our assumptions, we are expecting a deficit of **\$61,000**, which will have a significant offset from Facilities, leaving a consolidated deficit of **\$26,700**.

#### **Facility Budget Highlights**

- **Surplus Contribution:** The Facilities budget has a significant surplus that will continue to offset the Church's deficit.
- Occupancy & Rates: We're assuming a 6% office space vacancy rate and have increased rental rates by 8% to reflect inflation and market changes.
- **Events Income:** Events income exceeded expectations due to the SOTA contract, which is now a regular tenant. Wedding income is now combined into general events. We're confident about event income for the next fiscal year.
- **Long-Term Projects:** We're allocating \$500 to a Long-Term Projects budget under Operations for future maintenance, dependent on year-end budget status, with hopes to increase it as budgets stabilize.
- Staffing:
  - o Includes 2 staff people (all part-time)
  - o Small raises plus a 2.5% cost-of-living increase at midyear
- Community Breakfast: The program will begin contributing \$500/mo for building use expenses due to rising utilities, insurance, and downtown fees, but these payments will cease if the breakfast fund drops below \$30,000.
- New Rental Space: The old pastor's office is now rented at \$770/month (\$9,240/year).

#### **Planning for the Future**

While we hoped to break even this next fiscal year, we are planning for a deficit. Our focus for the upcoming year is renewal and growth with our full executive team in place. We remain optimistic about moving towards sustainability, especially with our facility consistently outperforming expectations. That said, growing our congregation is key to our financial sustainability.
